GUIDELINES FOR THE ISSUANCE OF VEHICLE STICKER(S)

1. The Membership & Communications Office shall issue the vehicle sticker upon presentation of the following:

- 1.a. Vehicle Sticker Application Form signed by the member or his/her registered spouse or dependent ;
- 1.b. Membership Card of the member or his/her registered spouse or dependent;
- 1.c. Recent LTO registration certificate of the member or his/her registered spouse or dependent;
- 1.d. Company car issued to member or his/her registered spouse or dependent must have an accompanying certification from the owner-company.

2. Vehicle Sticker Rates:

2.a For Individual, Corporate Proprietary & Assignees of Proprietary Members (Individual/Corporate) and their registered spouses and dependents:

- **First two stickers** - **Php 100.00 each**
- **Succeeding stickers** - **Php 150.00 each**

3. Vehicle Stickers can be charged to the account of the members or paid via cash at the Main Cashier.

4. Rules and Regulations:

- 4.a. VVCCI vehicle stickers are for VVCCI members only.
- 4.b. One vehicle sticker is valid for one vehicle registered with VVCCI.
- 4.c. Illegal use of VVCCI vehicle sticker is subject to tire lock and the following penalties:

- 4.c.1. First Offense - Php1,000.00**
- 4.c.2. Second Offense - Php2,000.00**
- 4.c.3. Third Offense - Php3,000.00**
- 4.c.4. Fourth Offense - Suspension of Membership**

- 4.d. Vehicle sticker shall be removed from the vehicle at the time of sale of the vehicle.
- 4.e. Vehicle sticker shall be placed by the authorized VVCCI personnel at the lower left corner of the car's windshield (*driver side*).

5. The vehicle stickers are valid from **January 2021 to December 2022.**
