GUIDELINES FOR THE ISSUANCE OF VEHICLE STICKER

- 1. The Membership & Communications Office shall issue the vehicle sticker upon presentation of the following:
 - 1.a. Filled out Vehicle Sticker Application Form duly signed by the member or his/her registered spouse or dependent;
 - 1.b. Membership Card of the member or his/her registered spouse or dependent;
 - 1.c. Photocopy of recent LTO Official Receipt & Certificate of Registration (OR/CR) of the vehicle under the name of the member. No need to submit the OR/CR for vehicles which are already in our registration file;
 - <u>1.d.</u> A Company Certification for vehicles not registered to the member but issued to him for official use.
 - 1.e. Copy of Sales Invoice or Deed of Sale for newly bought vehicles which are yet to be registered under the name of the member.
- 2. Vehicle Sticker Rates:
 - 2.a. For VVCC Proprietary Members and Assignees:
 - FIRST TWO STICKERS F R E E
 - SUCCEEDING STICKERS P200.00
- 3. Vehicle Stickers can be charged to the account of the members or paid in cash at the Main Cashier.
- 4. Terms and Conditions:
 - 4.a. VVCC vehicle stickers are issued to VVCC members Only. This is a privilege and not a right granted to members.
 - 4.b. One vehicle sticker is valid for one vehicle registered in the Club's file.
 - 4.c. Only vehicles with valid VVCC vehicle stickers are allowed access inside the basement parking.
 - 4.d. Illegal use of VVCC vehicle sticker maybe a ground for suspension or expulsion.
 - <u>4.e.</u> Vehicle sticker is Non-Transferable.
 - 4.f. Vehicle sticker shall be placed by the authorized VVCC personnel at the upper or lower corner of the car's windshield (driver side).
 - <u>4.g.</u> Vehicle sticker must be removed or stripped off from the vehicle upon transfer or sale to a third party.
- 5. The vehicle stickers are valid from January 2023 to December 2024.
