■ STEP 1

➤ **PRE QUALIFICATION** (30-DAY POSTING)

◆ **REQUIREMENTS**

- ☐ Application Form (*with endorsement from two (2) VVCC Regular Proprietary Members in good standing*)
- ☐ Interviewer Sheet
- ☐ Background Check Authorization & Disclosure Form
- ☐ Two (2) valid Government Issued IDs bearing with photo & signature
- ☐ Two (2) 2" x 2" latest photo
- ☐ Membership Status Confirmation (from Affiliated Clubs), if applicable
- ☐ Photocopy of Birth Certificate
- ☐ COE & Company ID (for Officer/Employee)
- ☐ Fee (Payable to Valle Verde Country Club, Inc.)

➤ **COMPLETION OF REQUIREMENTS**

- ☐ Photocopy of Birth Certificate
- ☐ Affidavit of Single Status or CENOMAR for aged 21 to 35 years old
- ☐ Two (2) valid Government Issued IDs
- ☐ One (1) 2x2 latest photo of Spouse & Dependents
- ☐ Specimen Signature Card

◆ **FOR ASSIGNOR**

- ☐ Stock Certificate (photocopy)
- ☐ Duly signed & Notarized Secretary Certificate of the Company or Board Resolution to designate company representative who will apply for membership with VVCCI, with a clause that the company and the representative will be jointly and severally liable to VVCCI for all accounts incurred by the representative
- ☐ Valid Government Issued ID bearing with photo & signature of Corporate Secretary

▪ **STEP 3**

➤ **INTERVIEW SCHEDULE**

♦ Upon submission of complete documents, applicants will be scheduled for interview by the membership committee.

▪ **STEP 4**

➤ **APPROVAL OF APPLICATION**

♦ Application will be elevated to Membership Committee and Board of Directors for approval prior to opening and closing of accounts of the concerned parties.

▪ **STEP 5**

➤ **RELEASING OF MEMBERSHIP CARD**

In the event of denial or rejection of application, the Membership Department will inform the applicant in writing to withdraw his/her application.
